**IMPORTANT NOTES:**

- 1) Examples are based on the assumption you have full Pell and student loan eligibility for the award year.
- 2) Please be aware that you must be enrolled in an eligible degree or certificate program to receive financial aid.
- 3) Pell Grant pays based on student eligibility and number of credit hours enrolled.
- 4) To receive student loans, your enrollment must be at least half time (6 credit hours). Estimated loan amounts are less loan fees.
- 5) If your enrollment includes all three terms, then you may be eligible to receive additional Pell Grant based on the 150% Eligibility Rule..
